bolistic admissions programs like the one that the University of North Carolina (UNC) has operated, consistent with Gratter v. Given the lengthy history of state-sponsord race-based preferences in America, to say that anyone is now victimized if a college considers whether that leaguey of discrimination has unequally advantaged its applicants fails to acknowledge the well-documented "intergenerational transmission of inequality that still plagues our citizenry." It is that inequality that admissions programs such as UNC's help to address, to the benefit of us all. Because the majority's judgment stunts that progress without any basis in law, history, logic, or justice, I dissent.
